

Empanelment period of the above Health Care Organisation was expired on 22.09.2013. Thereafter their empanelment have been extended upto 31.10.2013 vide this Deptt. order No.7763-F(MED) Dated 25.09.2013. However, their renewal process could not be completed till now due to procedural delay.

Accordingly, the Governor is pleased to extend the empanelment further period of the above Health Care Organisation up to 31.01.2014 on existing terms and conditions so that the beneficiaries under the West Bengal Health Scheme may get services there uninterruptedly. In the meantime, the Health Care Organisations shall have to complete the process of renewal of empanelment furnishing up-to-date Clinical Establishment License, up-to-date Fire Safety License, Memorandum of Agreement (MOA) and other requisite papers if not already furnished.


