NOTIFICATION

Subject: Creation of various posts in the office of the Director of Pension, Provident Fund & Group Insurance (DPPG), West Bengal.

Administration and online maintenance of General Provident Fund (GPF) of Group D employees of the State in the office Directorate of Pension, Provident Fund & Group Insurance (DPPG) under Finance Department has already been introduced in terms of order No. 734-F(J), dated 28.02.2018.


