MEMORANDUM

In order to remove confusion regarding implementation of F.D. Memo no. 1032-F(P2) dated 08.02.2019, the undersigned is directed by order of the Governor to say that the enhancement of Rs. 2000/- as envisaged in FD Memo no. 1032-F(P2) dated 08.02.2019, will be added w.e.f. 01.02.2019 to the amount of the present fees/remuneration, as stood on 31.01.2019 in respect of individual personnel who have already got one or more enhancement by this time in terms of Memo No. 5859-F(Y) dated 22.07.2013. The next annual enhancement will be as usual i.e. on the amount that will stand on the respective date of enhancement of each such personnel, provided that Professional Fee of Senior Software Developer shall not exceed Rs. 42000/- per month.

Data Entry Operators, who have been engaged in terms of F.D. Memo No. 2500-F(Y) dated 20.03.2015, will also come under the purview of Memo no. 1032-F(P2) dated 08.02.2019 for such enhancement.
