As per amendments in the West Bengal Rules of Business vide Home & Hill Affairs Department's Notification No.181-Home(Cons)/R2R(Cons)-08/2016, dt.09.03.2017, Department of Large Industries & Enterprises has been renamed as Department of Industry, Commerce & Enterprises.


Of late, it has also come to the notice of the Govt. that inclusion of Parliamentary Affairs Department in FA Cluster-13 vide this Department's Memo. No. 250-F(Y), dt.13.01.2017 has been causing inconvenience to the administrative department.

Under such circumstances, it is felt necessary to make some additions and alterations in the FA cluster.

Now, in partial modification of this Department's Memo. No. 250-F(Y), dt.13.01.2017, Department of Industry, Commerce & Enterprises is substituted in FA Cluster-33 for Department of Large Industries & Enterprises and Parliamentary Affairs Department is shifted from FA Cluster-13 to FA Cluster-2 for administrative convenience. Consequent upon merging of Department of Micro, Small & Medium Enterprises & Textiles with Department of Industry, Commerce & Enterprises, FA Cluster-30 will remain non-operational for the time being. On such re-arrangement in FA Cluster, the position of the concerned Administrative Departments in the FA Cluster will be as under:


