

M E M O R A N D U M

In continuation of this Department Memo No. 2448-FB dated 28.03.2024, Memo No. 365-FB dated 28.06.2024 & Memo No. 1490-FB dated 04.02.2025, the Governor has now been pleased to decide as follows:

- [A] To release fund upto 100% of the whole year's Budget Provision for the financial year 2024-25, under Detailed Head "52- Machinery & Equipment", "53-Major works" and "60- Other Capital Expenditure", relating to Capital Heads of Account, pertaining to Major Heads 4046 to 5475.
- [B] While issuing orders for sanctioning expenditure in exercise of the powers delegated under this Memorandum, the following sentence should be inserted in such orders "This order issues in exercise of the powers delegated under Finance Department Memo No.1717-FB dated 12.03.2025".
- [C] The powers delegated to the Administrative Departments / controlling Authorities to release fund are subject to restrictions on creation of posts, purchase / hiring of cars and also other restrictions in terms of para (C) of F.D. Memo No. 2448-FB dated 28.03.2024, are to be observed.
- [D] This order will be effective from date of issue.
