Note:- (1) Enrolment under the Health Scheme is open up to 31-03-2012.

(2) Retired Government employee/ family pensioner whose pension has not yet been finalised and got no P.P.O. number is also entitled to enroll his/ her name under the Health Scheme. Such pensioner will get the benefits of the Scheme on the basis of Temporary Family Permit till he/ she gets P.P.O. number.

(3) Retired Government employee who was a member of the West Bengal Health Scheme, 2008 while on service will get the benefits of the Scheme from the next date of his/ her retirement as pensioner. Identity Card/ Temporary Family Permit may be given following the provisions of the F.D. Notification No. 8219-F (MED), dt. 19-08-2011. Concerned Treasury/ Bank may be informed of properly.
