**MEMORANDUM**

With a view to implementing Integrated Financial Management System (I.F.M.S.) successfully, the State Government has made available a land-line telephone with broad-band internet connection to the D.D.Os. who have no direct land-line telephone and broad-band connection in their office vide Finance (Audit) Department's Memo. No.9055-F(Y), dated 30.12.2013.

Of late it has been observed that a great many administrative departments are sending proposals for sanction of installation of land-line telephone connection with broad-band facility for the D.D.Os. without furnishing any information as to how many telephone lines with / without broad-band facility already exist in their offices.

Under such circumstances, while seeking permission from Finance Department for installation of land-line telephone connection with broad-band facility in their office, all the administrative departments are now requested to furnish the following information :

Name of the office :

Telephone No. (1)	Used by the Officer (Designation) (2)	Whether approval of Finance Department obtained (3)	If yes, furnish U.O. No. and date (4)	If there is a broad-band connection, attached with this Telephone? (Yes / No) (5)

In addition to the above, the departments are advised to install a LAN Connection in the offices so as a larger number of Desktops may have internet access with one or two broadband connections instead of having broadband connections in larger numbers of land-line telephones.

This order shall take immediate effect.


