

Memorandum

The last date of online enrolment under West Bengal Health For All Employees and Pensioners Cashless Medical Treatment Scheme, 2014 (hereinafter called the said scheme) and accordingly validity of existing card and reimbursement facility as per erstwhile WBHS, 2008 was extended from 1st Oct ,2017 to 31st March, 2018 vide FD Memo No. 890-F(MED) WB Dated 22.09.2017. However, on further assessment it has been found that still a substantial numbers of Government Employees and specially Pensioners are yet to register themselves online in West Bengal Health Portal (<https://wbhealthscheme.gov.in>).

Therefore, the Governor is further pleased to extend the last date of online application for enrolment under the said scheme and accordingly validity of existing card and reimbursement facility as per WBHS, 2008 from 1st April ,2018 to 30th September, 2018 . The other terms and conditions of the FD Memo No. 282-F(MED)WB Dated 30.03.2017 will remain unaltered.


