MEMORANDUM

At present 20 Departments are engaged in the Rural Infrastructure Development Fund (RIDF)/Warehousing Infrastructure Fund (WIF) projects. All Departments for issuance of Administrative Approval to NABARD are sending files to respective Groups of Finance Department (if the value of the projects is more that the delegated power of the Administrative Department). Then after approval of Finance Department, the Administrative Departments issues Administrative Approval. Again, for release of fund under RIDF/WIF all Administrative Departments are sending files to Gr. N of FD through e-Office package.

For speedy execution and implementation of RIDF/WIF projects, in accordance with F.D Order No. 2652-F(Y) dated 14.09.2020, all Administrative Departments had been requested with effect from 01.10.2020 to issue Administrative Approval and Financial Sanction from their end without referring the cases to Finance Department.

In this context, the Governor has now been pleased to decide to release further fund up to 25% of Budget provision of 2021-22 under the RIDF heads of account minus fund released till date under the following 20 (twenty) executing departments in the manner as detailed below:
