**ORDER**

The undersigned is directed by order of the Governor to say that the Governor has been pleased to sanction Rs.86,00,000/- (Rupees eighty six lakh only ) for the in-service training of a batch of 25 (twenty five) officers of Constituted State Services at OP Jindal Global University(OPJGU), Haryana in the first phase from 02/10/2017 to 06/10/2017 and at LKY School of Public Policy, Singapore from 09/10/2017 to 13/10/2017.

2. The said total programme fee includes:
  - i) Air fare from Kolkata to Delhi, Delhi to Singapore and back to Kolkata.
  - ii) Other charges:
    - a) Visa fees
    - b) Conveyance charges from Delhi Airport to OPJGU ; from OPJGU to Delhi Airport on termination of the domestic leg of training at OPJGU; from Singapore Airport to Hotel at Singapore and to the University to and fro; from Hotel at Singapore to Singapore Airport on termination of training at Singapore;
    - c) Course fees including course materials and food and lodging charges at OPJGU and Hotel at Singapore.
3. 50% of the total programme fee of Rs.86, 00, 000/- i.e. Rs.43,00,000/- (Rupees forty three lakhs only) will be paid to the O.P. Jindal Global University in advance to enable them to procure Air tickets and make deposits to the foreign university in advance.
5. O.P. Jindal Global University shall submit the copies of Air tickets and money receipt and/or relevant documents regarding deposits made in favour of the foreign university with proper authentication so as to enable the Department to adjust the advance drawal within the current financial year, 2017-18.
6. Final payment will be made to the O.P. Jindal Global University after submission of the final bill by the university on completion of the entire training programme.
7. The expenditure involved will be debitible to the Head of Account "2052-00-090-NP-038-Training of Non State Civil Service (Non SCS) Officers-98-00-V" pertaining to Demand No. 18 in the budget for the financial year 2017-2018.
8. Necessary fund will be allotted in favour of the Assistant Secretary and D.D.O., Finance (Accounts) Department through e-bantan under IFMS.
9. This order is issued with the concurrence of the Finance Department vide U.O. No.0579, dated 19/06/2017 of the Group N-Budget Branch and U.O. No. Group T/2017-2018/0299, dated 14/07/2017 and with the approval of the competent authority.
10. All concerned are being informed accordingly.
