Consequent upon completion of the period of engagement of Accounts Officer (Audit) from the retired officers of WBA&AS and in continuation of Finance Department earlier orders no. 3525-F(Y)/WB dated 02.09.2016, 4023-F(Y)/WB dated 21.10.2016 and 528-F(Y)/WB dated 10.02.2017, the Governor is pleased to extend the period of engagement of **18 (eighteen)** retired officers out of existing 19 (nineteen) retired officers of West Bengal Audit & Accounts Service whose names are incorporated in the enclosed **Annexure - A** to the post of Accounts Officer (Audit) on **contract basis** in the same FA cluster under the respective Financial Advisor for a period of 06 (six) months or attainment 65 (sixty five) years of age whichever is earlier after completion of their existing 1(one) year term.

2. Out of 19 (nineteen) Accounts Officer (Audit) currently working in different FA clusters, 1 (one) retired officer viz. Shri Rabindranath Halder II, presently engaged in the FA Cluster 9 & 26 comprising Forest & Environment, ARD & Fisheries, will attain 65 years of age on 29.10.2017 and his period of engagement would terminate on attainment of 65 years of age or completion of existing 1 year contractual engagement whichever is earlier. All Accounts Officer (Audit) whose names are incorporated in the enclosed **Annexure - A** are hereby directed to report to the Secretary of the concerned department through Financial Advisor of the respective cluster for completion of joining formalities for extended period of contractual engagement as Accounts Officer (Audit).
