
Sub: Disbursement of Salary, Wages/Honorarium, Pension and financial assistance for the month of September and October, 2022.

Finance Department had earlier issued Memo No. 6454-F(Y) dated 27.08.2015 specifying the dates on which the salaries including salary under Grant-in Aid, wages, remuneration, stipend, honorarium, pension, etc. are to be paid on monthly basis.

Since the State Government offices will remain closed during the period from 30th September to 10th October, 2022 and 22nd to 27th October 2022, it is decided to disburse the salary, wages, stipend, pension and financial assistance for the month of September and October, 2022 as follows:

- i. Salary including Grant-in-Aid salary, Wages, remuneration, stipend, honorarium for the month of September and October, 2022 will be paid on 28th & 29th September, 2022 and 21st October, 2022 respectively.
- ii. Pension for the month of September and October, 2022 will be disbursed on 29.09.2022 and 01.11.2022 respectively.
- iii. Financial assistance under scheme like Jai Bangla, Lakshmir Bhandar and etc. for the month of October, 2022 shall be credited to the nodal bank account within 26th September, 2022, so that the respective amount can be credited to the beneficiaries' bank account by DBT within 28th September, 2022.


