**ORDER**

The undersigned is directed by the order of the Governor to state that the Governor is pleased to accord approval to 25 (twenty five) officers of 09 (nine) constituted State Services (at Annexure "A") to participate in the in-Service training programme on Public Finance and Budgeting.

2. The training programme shall be in two phases:
  - i. Domestic Leg at the O.P. Jindal Global University, Haryana from 2<sup>nd</sup> October 2017 to 6<sup>th</sup> October 2017; and
  - ii. Foreign Leg at the Lee Kuan Yew School of Public Policy, Singapore from 9<sup>th</sup> October 2017 to 13<sup>th</sup> October 2017.
3. The participants will leave for O.P. Jindal Global University, Haryana from Netaji Subhas Chandra Bose International Airport, Kolkata on 1<sup>st</sup> October 2017 and will return to Kolkata after completion of training programme in Singapore.
4. All the expenses in connection with the training, logistics, accommodation, airfare, visa charges and travel for both domestic and foreign leg of the training programme will be borne by the State Government in terms of this Department Order No. 3313-F(Y)/WB, dated 18<sup>th</sup> July 2017.
5. Participants will be entitled to daily allowance @ $\frac{1}{4}$ <sup>th</sup> of US\$ 75 per diem in terms of Order No. Q/FD/695/3/2000, dated 21<sup>st</sup> September 2010 issued by Ministry of External Affairs (FD Section), Government of India during their stay in the Foreign Training Leg in Singapore.
6. Cadre Controlling Authorities of the respective State Services are requested to release the participants (at Annexure "A") for the entire period of training in India and Singapore, i.e. from 1<sup>st</sup> October 2017 to 14<sup>th</sup> October 2017.
7. This order issues with the approval of the Competent Authority.


