**MEMORANDUM**

The undersigned is directed by order of the Governor to make the following amendment in Item No.29(C) inserted in Schedule 'A' under Rule 18 of the Delegation of Financial Powers Rules, 1977 vide this Department's Notification No.5320-F(Y), dated 22.06.2012.

The existing provisions of Item No.29(C) of Schedule 'A' under Rule 18 as contained under the column 'Items of Expenditure' of the aforesaid Notification may be replaced with the following —

“Purchase, repairs and Annual Maintenance Contract (AMC) of computers with peripherals including UPS and printer, LAN, storing devices such as pen drives, compact discs (CD), removable hard discs and antivirus software”.

2. All other provisions of Item No.29 of Schedule 'A' under Rule 18 of Delegation of Financial Powers Rules, 1977 as inserted under Notification No.5320-F(Y), dated 22.06.2012 and the financial powers delegated thereunder shall remain unchanged.
3. Necessary amendment in Delegation of Financial Powers Rules, 1977 will be made in due course.
