MEMORANDUM

In continuation of this Department's Memo. No. 4021-F(Y) dated 16.07.2019, the undersigned is further directed by order of the Governor to say that the funds transferred to LF/PL/Deposit/Bank Account for the financial year 2018-19 for the following purpose/scheme need not be refunded:

- 1. BEUP fund allotted FY 2017-18 onwards,
- 2. Projects under RIDF XXIII,
- 3. 4th State Finance Commission Grant,
- 4. West Bengal Urban Employment Generation Scheme fund allotted FY 2018-19 onwards,
- 5. Fund released for Gangasagar Mela, 2019
- 6. Fund for Salary/Wages allotted FY 2018-19 onwards.

It is further clarified that the fund lying in Deposit Accounts/Bank Accounts on account of Security Deposit/EMD of Contractors, Govt.'s Contribution in equity share, Taxes and Statutory duties like TDS/TCS/Labour Cess as per FD's Memo. No.5103-F(Y) dated 27.06.2016, are not unutilized fund and therefore are not to be refunded.

Government Loan given to the Organizations are to be refunded as per the specific terms and conditions of the Loan and not merely on expiry of a Financial Year.

However, the Operator/Administrator of LF/PL Accounts, while preferring claim on account of the above noted schemes/projects/funds should give proper certification as specified below on the physical copy of the payment advice to enable the Treasury Officer to know the nature of such claims:

"It is certified that the Payment advice has been generated from the fund lying in LF/PL/Deposit Account for (the appropriate option from the following is to be mentioned):

- i) BEUP fund allotted FY 2017-18 onwards.
- ii) Projects under RIDF XXIII.
- iii) 4th State Finance Commission Grant.
- iv) West Bengal Urban Employment Generation Scheme fund allotted FY 2018-19 onwards.
- v) Fund released for Gangasagar Mela, 2019.
- vi) Fund for Salary/Wages allotted FY 2018-19 onwards.
- vii) EMD/Security Deposit of Contractors.
- viii) Government Contribution in form of equity shares, etc.
- ix) Taxes and Statutory deductions as per FD Memo No. 5103-F(Y) dated 27.06.2016
- x) Deposit Works of non Government Institutions."

This order will take immediate effect.
