NOTIFICATION

WHEREAS The West Bengal Non-Government Educational Institutions & Local Authorities (Control of Provident Fund of Employees) Act,1983 (West Bengal Act XXXIX of 1983) (hereinafter referred to as the said Act) provides for deposit and maintenance of Provident Fund in the Government Treasury in respect of employees of non-government educational institutions and local authorities in West Bengal;

AND WHEREAS The Kazi Nazrul University constituted under the Kazi Nazrul University Act of 2012 (hereinafter referred to as the said University) has moved the State Government for being governed by the provisions of the said Act and Rules made thereunder vide their Notification No KNU/VC/19/24 Dated 27.11.2019 in the matter of deposit, control & management of provident fund of their employees;

NOW, THEREFORE, in exercise of powers conferred by sub-section (3) of section 1 of the said Act, the Governor is, hereby, pleased to order that the said Act shall come into force for the said University with effect from 01.01.2020.


