In partial modification of this Department's Memo No. 3641-F(Y) dated 28.06.2019, it has been further decided that paragraph B.(1) will be substituted by the following paragraph:

In case of offices under Works / Forest Departments,
 (a) if such work and engagement is related to some Project then the remuneration may be charged to the Project cost. Bills may be drawn either in TR 70 (easy bill) or TR-26 (vouched bill) for the worker engaged through agency. When workers are engaged by Government Offices and wages are paid through Master Roll, bill shall be drawn as vouched bill in TR-26.

In both the above cases, the charge is debitable to the detailed head - "53", "87" "27" "60" or "19" as the case may be.

(b) If such work and engagement is not related to any project, the remuneration of workers to be drawn as vouched bill in TR 26 under detailed head "19" or "50" as the case may be.

All other provisions contained in Memo No. 3641-F(Y) dated 28.06.2019 shall continue to apply.

This order will take immediate effect.
