## **MEMORANDUM**

## Sub: Mandatory collection of Tax and Non-Tax receipts through GRIPS

This is to bring to your kind information that at present nearly 90% of the State Tax or Non-Tax revenues are collected through Government Receipt Portal System (GRIPS), whereas considerable amount of receipts are still being collected outside GRIPS in manual TR-7 challan.

It has been found that Departments like Land & Land Reforms and Refugee Relief & Rehabilitation, Transport, Health & Family Welfare, Home and Hill Affairs, PWD etc. and Directorates like Directorate of Electricity Duty etc are still collecting their taxes outside GRIPS.

- 1. In terms of G.O. 4630-F(Y) dated 15.06.2015 and 5074-F(Y) dated 30.06.2015 of Finance Department, all Departments and Directorates were requested to collect their tax and non-tax receipts mandatorily through GRIPS except those which have has been exempted vide G.O. No. 5100-F(Y) dated 01.07.2015 and 5158-F(Y) dated 02.07.2015.
- 2. Through GRIPS deposit of revenue, taxes etc can be made by individual depositors and as well as by the Govt. offices.
- Further GRIPS facilitates payment through Online mode (i.e. Net Banking & Debit Card covering 22 banks) and as well as Offline mode (i.e. Over the Counter covering 19 banks).
- 4. Recently 'Payment Gateway -SBI ePay' has also been integrated with GRIPS. The new facility as an additional benefit provides certain other payment options like Credit Cards, eWallet and UPI. Furthermore, the said payment gateway provides net banking facility with 46 banks and Corporate Banking with 22 banks.
- 5. No additional charges are required to pay by the depositors for using Credit Card, Debit Card, Net Banking, UPI, Wallet in GRIPS.

Therefore, all Departments/Directorates are requested again to collect their tax and non-tax revenue mandatorily through GRIPS. In this regard the Administrative Departments are also requested to issue necessary instructions to their subordinate office(s) accordingly.
