**Memorandum**

The Financial Advisor set-up was re-arranged for the various administrative departments vide FD's Memo. No.250-F(Y), dt.13.01.2017 and in terms of this Memo., the Department of Micro, Small & Medium Enterprises & Textiles was included under FA Cluster-30.

Consequent upon merging of the Department of Micro, Small & Medium Enterprises & Textiles with the Department of Industry Commerce & Enterprises, FA Cluster-30 became non-operational and in turn, the MSME & T wing came under FA Cluster-33 with the Department of I C & E vide FD's Memo. No.1642-F(Y), dt.20.03.2017.

Subsequently, as per amendments in the West Bengal Rules of Business vide Home & Hill Affairs Department's Notification No.593-Home(Cons)/R2R(Cons)-02/2017, dt.24.08.2017, the Department of Micro, Small & Medium Enterprises & Textiles has been emerged as individual department.

Under such circumstances, in partial modification of this Department's Memo. No. 1642-F(Y), dt.20.03.2017, the Governor is now pleased to restore FA Cluster-30 to the Department of Micro, Small & Medium Enterprises & Textiles.


