Subject: Permission for making payment through Cheque instead of RTGS to the Rayats'/ Seller's bank A/cs for registration of land, <u>purchased under Direct Land Purchase Policy</u>.

At present, private lands are being purchased directly from the Rayats/ Sellers for implementing important Government projects and payments are being made through RTGS to the Bank Accounts of the Rayats/Sellers through IFMS.

It has been brought to the notice of the Government that sometimes Rayats/Sellers are not appearing at the Office of ADSR at the time of Registration of the Sale deeds in spite of payment being credited to their bank accounts. On the other hand, if the Rayats/Sellers are not ensured of getting payment, they may not execute the sale deeds causing hindrance in timely execution of Government projects.

With a view to ensuring the presence of the Rayats/ Sellers at ADSR office at the time of Registration, the undersigned is directed by order of the Governor to say that in relaxation of normal procedure of making payments through DBT, the concerned Treasury Officer shall issue Cheques in favour of the Rayats/Sellers on request of the drawing officer.

This order will take immediate effect.
