Sir/ Madam,

The Annual Budget for Financial Year, 2020-21 will be presented to the Legislative Assembly during the last quarter of the current financial year. Finance Department has taken up the work for preparation of Revised Estimates, 2019 – 20 and Budget Estimates, 2020 – 21. The process of formulation of Budget will require to be completed sufficiently early. You are, therefore, requested to take immediate steps for formulation of Revised Estimates (RE), 2019 – 20 and Budget Estimates (BE), 2020 – 21 for Expenditure and Receipt. While formulating Revised Estimates, 2019 – 20 and Budget Estimates, 2020 – 21 for Administrative Expenditure, the Directorates may send proposal for expenditure other than "01-Salaries". The RE and BE of "01-salaries" pertaining to "Administrative Expenditure" shall be formulated from the end of the Group-N, Finance Department.

While framing the "Revised Estimates" for expenditure, following factors should be considered and RE should include:

- 1. All anticipated expenditure of the current financial year;
  - 2. Re-appropriation of funds already made or proposed to be made;
  - 3. New Sub Heads that have been opened or supposed to be opened during the current financial year;
  - 4. Additional funds released during the current financial year;
  - 5. Any other relevant factors that have a bearing on the expenditure during the current financial year.

"Budget Estimates" of expenditure should be prepared on assessing the requirements with reference to all available data. Actuals for the previous year and Revised Estimates for the current financial year should form the basis for preparing Budget Estimates for coming financial year, making due allowance for any special factors. It should be ensured that all inescapable and foreseeable expenditure is incorporated in Budget Estimates for next financial year.

Any substantial deviation in estimates from the previous year's actuals should be corroborated with appropriate reasons. In case of any new Head of Account are supposed to be opened during the last quarter of this financial year; separate

proposals should be sent to Finance Department to incorporate such probable expenditure / receipts within RE, 2019 - 20 and/or BE, 2020 - 21.

The economy instructions already in force should be kept in view while framing the budget proposals for Revised Estimates, 2019 – 20 and Budget Estimates, 2020 – 21.

The budget proposals should be furnished within 15th November, 2019 in the format enclosed herewith. A soft copy of same in MS Excel format should be sent through email to <a href="mailto:dbhattacharyya5@gmail.com">dbhattacharyya5@gmail.com</a>.

This may be treated as urgent.
