Applications are again invited for the post of Judicial Member in the West Bengal Administrative Tribunal in plain white durable paper in the prescribed format in a closed cover, addressed to the Principal Secretary, Finance Department, Government of West Bengal, Writers' Buildings, Kolkata- 700 001. The application must reach the office of the Finance Department, Government of West Bengal within 17.30 hours of April 16, 2013. The persons who had applied in response to our earlier advertisement dated 25.09.2012 need not apply afresh.

2	Selection Procedure Rule 5(2) of the Administrative Tribunals (Procedures for appointment of Members) Rules 2011	Selection will be made out of the list of applicants forwarded by the Judicial Department, Government of West Bengal and applicants responding to the advertisement. As per the decision of the Selection Committee, after receipt of names for the post of Judicial Member, initial scrutiny will be done to check the eligibility of the applicants for the post. The panel of names of eligible applicants will then be placed before the Selection Committee for consideration and recommendation.
3	Qualification (Section 5 of the Administrative Tribunals (Amendment) Act, 2006	A person shall not be qualified for appointment- as a <b>Judicial Member</b> , unless he is or qualified to be a Judge of a High Court or he has for at least two years held the post of a Secretary to the Government of India in the Department of Legal Affairs or the Legislative Department including Member-Secretary, Law Commission of India or held a post of Additional Secretary to the Government of India in the Department of Legal Affairs and Legislative Department at least for a period of five years.
4	Term of Office Section 7 (2) of the Administrative Tribunals (Amendment) Act, 2006	A Member shall hold Office as such for a term of five years from the date on which he enters upon his Office extendable by one more term of five years; Provided that no Member shall hold Office as such after he has attained the age of sixty-five years.
5	Condition of service Section 7 (3) of the Administrative Tribunals (Amendment) Act, 2006	The conditions of service of Chairman and Members shall be the same as applicable to Judges of the High Courts.
