Sub. : Grant of Dearness Allowance to the State Government employees, Teachers and Non-teaching employees of Non-Govt. Educational Institutions / Employees Statutory Bodies / Govt. Undertakings / Panchayats including Panchayat Karmee and Municipal Corporation / Local Bodies etc. who are drawing their pay in the pre-revised scale with effect from 01.04.2010.

The undersigned is directed to refer to this Department Order No. 2580-F(P) dated 06.04.2010 revising the Dearness Allowance with effect from 01.04.2010 in respect of the State Government employees, Teachers and Non-teaching employees of Non-Government Educational Institutions / Employees Statutory Bodies / Government Undertakings / Panchayats including Panchayat Karmee and Municipal Corporation / Local Bodies etc. who are drawing their pay in the pre-revised scale of pay.

The rates Dearness Allowance to the above categories of employees shall stand enhanced from the existing 64% to 73 % w.e.f. 01.04.2010. All other conditions as laid down in 10902-F(P) dated 09.12.2009 will continue to apply.

The Dearness Allowance sanctioned hereinabove shall be rounded off to the nearest rupee in each case.
