MEMORANDUM

In the recent past many State Government Secretariat-Establishments of different Departments, Directorates and other Regional Offices have been shifted from Kolkata to Salt Lake Bidhannagar. The Drawing & Disbursing Officers [DDO] of all such Offices were originally attached with the Kolkata Pay & Accounts Offices. At present, some of those offices which were shifted from Kolkata to Salt Lake have been linked with the Bidhannagar Treasury and some offices are still now attached with the Kolkata Pay & Accounts Offices linked with the Reserve Bank of India, Kolkata for drawing their bills and cheques. The official of these Offices, which have been shifted to Salt Lake but are still now attached with the Kolkata Pay & Accounts Offices use to visit from Salt Lake to Kolkata Pay & Accounts Offices and the RBI almost every day which causes delay in carrying out financial business of their offices. Moreover, the infrastructure of the Bidhannagar Treasury is not sufficient to handle the job of such huge numbers of DDOs. To overcome these problems it has been decided by the Government to establish a new Pay & Accounts Office at Salt Lake.

2. After careful consideration of the matter, the Governor has been pleased to accord sanction to the establishment of a Pay & Accounts Office with Cheque system of payment at Bidhannagar, Salt Lake under Rule 2.01 of the West Bengal Treasury Rules, 2005. The new Pay & Accounts Office shall be located at the 1st Floor of I.B. Market, Sector-III, I.B. Block, Bidhannagar, Salt Lake. Kolkata-700 091 and shall be called as Pay & Accounts Office-III.

3. The Government has already sanctioned 74 (seventy four) posts for the New Pay & Accounts Office at Salt Lake vide Memorandum No.1527-F(Y) dated 01.03.2010.

4. The Secretariat-Establishments of the Departments, Directorates and other Regional Offices under this Government situated in the Salt Lake and its adjacent area shall come under the jurisdiction of this Pay & Accounts Office. The Pay & Accounts Office-III shall start functioning under fully computerized system under the Treasury Code: "CAF".

5. The State Bank of India, Bikash Bhaban Branch, Salt Lake, which is already functioning as the agency bank of Reserve Bank of India for Bidhannagar Treasury; shall temporarily be linked with the Pay & Accounts Office-III at Salt Lake.

6. 161 [one hundred sixty-one] number of Drawing & Disbursing Officers and 14 [fourteen] number of Operators of the Deposit Accounts shall be attached with the Pay & Accounts Office-III. The lists of the Drawing & Disbursing Officers and the Operators of the Deposit Accounts along with their new DDO-Codes are annexed with this Memorandum.

7. The regular Pay Bills for the month of March 2012 payable in April 2012 and all other bills out of budget allocation in the Financial Year 2012-13 and onwards of these Drawing & Disbursing Officers attached with the Pay & Accounts Office-III shall be presented at Pay & Accounts Office-III.

8. This order shall take effect from the date of its issue.

9. The Principal Accountant General(A&E), West Bengal, the Reserve Bank of India, PAD, Kolkata and others are being informed.
