2. The Governor has further been pleased to order that the aforementioned officers will enjoy the pre-revised Scale No.19 as detailed above as personal to them without any change of designation and nature of duties.

3. The pay fixation order in respect of afore said officers will be issued centrally by the Service Cell, Gr. T of Finance Department.

4. While issuing pay fixation order on the basis of this notification, at first the pay in respect of the afore mentioned officers wherever applicable shall be refixed in terms of the Notifications dated 23.09.2010 and 26.10.2010 respectively and there after the fixation will be made accordingly.

5. There would be no recovery arising out of such re-fixation in pursuance of Notifications dated 23.09.2010 and 26.10.2010 issued from the Finance Department in respect of the petitioners involved in the **COST No.08 of 2011** in the **Hon'ble High Court** and also in the **O.A. No.1495 of 2010, O.A. No.130 of 2011 & O.A. No.1260 of 2010** in the **WBAT** until further orders are passed by the **Hon'ble High Court** in the matter of **COST No.08 of 2011**

6. This scale benefit is purely provisional and will be guided by the result of the Court Case (bearing no. **C.O.S.T 2 of 2012**) pending with the Hon'ble Calcutta High Court.


