*A Revised guideline allowing the benefit of revised pay structure under WBS(ROPA) Rules, 2009 for the re-employed pensioners who retired before 01.01.2006 and those who retired on and after 01.01.2006 has been issued under F. D's Memo No. 3951-F dt. 27.05.2009.*

2. *Since actual benefit of fixation of pay in the revised pay structure has been allowed to all State Government employees with effect from 01.04.2008, a question has been raised whether the benefit of fixation of remuneration of the re-employed pensioners will be allowed with effect from 01.04.2008 instead of 01.04.2009 in modification of F. D. Memo No. 3951-F dt. 27.05.2009 as some re-employed pensioners have been engaged on re-employment even before 1<sup>st</sup> April, 2008.*

3. *After careful consideration of the matter, in partial modification of the F. D. Memo No. 3951-F dt. 27.05.2009, the undersigned is directed by order of the Governor to state that the benefit of revised pay structure to the re-employed pensioners of this Government will be admissible with effect from the actual date of effect of the WBS (ROPA) Rules' 09 i.e from 01.04.2008 instead of 01.04.2009*
